No News Gag On Rapist Attacks

Confronted by recent criticism of the sheriff's handling of information about the east area rapist, Sacramento County sheriff's spokesman Bill Miller said Thursday he has told news media of all the rapist's attacks and will continue to do

"It's our policy to release the information to the media each time that guy strikes," Miller told the Sacramento Public Relations Roundtable as he

accepted its Public Relations Professional of the Year award.

But the sheriff's staff will continue to deny general interviews about the rapist and the attacks which have outraged the eastern section of the county, Miller said. That policy was set because reporters asking about the rapes were disrupting the sheriff's office, he said. "The office was beginning to look like an NBC production studio."
