Davis Council Session On Rapist Draws 400

DAVIS — Some 400 residents of this university community poured into a special City Council meeting Tuesday night to hear tips on how to deal with the East Area rapist, the sexual terrorist who recently added three Davis women to his list of 39 attacks.

"The level of paranoia is getting phenomenal," explained Mayor Tom Tomasi. "This is just raw fear."

Police Chief B.D. Bartholomew said he has not seen Davis residents so upset "since the Vietnam War."

He implied that he did not blame them, saying the stymied Police Department has obtained a researcher to go through the rape reports involving the ski-masked invader to see if there might be some common denominator in them the 40-member police force has overlooked.

Davis police are as stumped as Sacramento police, Sacramento County sheriff's deputies, Stockton police and Modesto police in trying to identify or capture the East Area

"He (the rapist) has a pretty warped personality but he's also pretty shrewd," Bartholomew said. "Every middle run murderer or rapist makes a mistake, but this guy hasn't made a mistake."

"We are convinced he does select his hits (victims) ahead of time. He knows where he is going when he comes into town," Bartholomew said. The rapist also seems to know the best ways of escape, Bartholomew said.

The police chief of 16 years refused to answer some of the questions the audience raised in the two-hour special meeting, saying, "We could be waving a red flag in his face by telling everything he does."

But he did try to dispell the rumors of mutilation that seem to have followed the rapist since he first emerged in Sacramento County June 18, 1976.
